

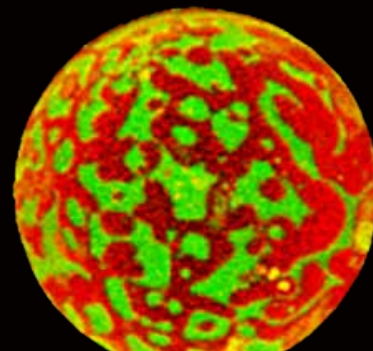

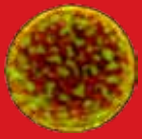

In 2001 Development Capital Networks, serving as manager of the National Association of Seed and Venture Funds (NASVF), was approached by the Federal Laboratory Consortium with a tech transfer conundrum. The FLC was seeking a way to introduce federal lab technologies to investors and Fortune 100 licensees. The NASVF was looking for new sources for deal flow for their investor-members. The concept quickly took form and in 2002, Development Capital Networks (DCN) launched the first ever World's Best Technologies (WBT) forum in Pittsburgh, PA.

Today, the WBT Innovation Marketplace has emerged as the premier forum of pre-screened, prepped, undiscovered companies and technologies, sourced from universities, labs, and garages located across the country and around the globe. The WBT is the culmination of a year-long effort of investors, licensees, and tech commercialization professionals. The WBT is deal-focused and industry-diverse, showcasing companies and technologies that vary by geography, funding source, and type of research institution.

Now in its 10th year, the WBT has sourced, screened and mentored 630 companies and technologies from coast-to-coast, and from more than 25 countries. Nearly one in three WBT Innovation Marketplace presenters goes on to secure venture capital, license their technology, or sell their IP outright. More than \$500 million in private capital has been invested in WBT technologies.

The 2011 WBT Innovation Marketplace was presented by Lockheed Martin Corporation, and hosted by the Center for Innovation, in association with the Office of the Governor of Texas, and the University of Texas at Arlington.

These advantages open the door for chip-based solutions that were previously unobtainable.

Several months before each event, applications for presenting companies and technologies undergo an extensive selection process. Roughly 80 venture capitalists, licensing scouts, and angel investors evaluate the applications. The selections are based on the technology's market position, commercialization readiness, overall market potential, technology strength, management team and value proposition.

Applications are returned to the WBT team with a recommendation and feedback. All feedback is provided to the applicant at no cost, whether the applicant is accepted or declined.

Participating in the WBT screening provides venture investors and licensing professionals an early look at all the WBT applications. Qualified investors and licensees are invited to participate in the screening process. **how applications are selected**

The WBT Screening Committee scores each technology application and provides written comments. Consideration is given based on the science team, strength of technology or product, position in the technology marketplace, the market opportunity, the value proposition, the business model, and the management team. At the conclusion of the screening process applicants will have an opportunity to view all reviews and feedback for each application submitted. **There is no cost to apply. If selected, presenters are required to pay a standard “early bird” registration fee.**

Each presenter receives one-on-one mentor support in the weeks leading up to the WBT. WBT Mentors represent a wide variety of expertise and assist presenters in the development of a concise 6- minute presentation. Both novices and experts alike find value in networking with their mentors and working with them on creating or refining an investor/licensee oriented presentation.

In addition to offering best practices and setting expectations, mentors and critics get an early look at some of the technologies that will be at the event. Mentoring takes place in the 2 months leading up to the event. WBT Mentors and “Critics” also participate in Dress Rehearsal conference calls 2 weeks prior to the WBT, and offer a last round of feedback on presenters’ pitches.

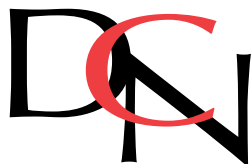

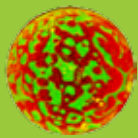

**About the Center for Innovation**
